Subj: ESTABLISHMENT OF MARITIME FORCE PROTECTION COMMAND
(MARFPCOM), NORFOLK, VA

Ref: (a) OPNAVINST 3111.14V
(b) SNDL (OPNAVNOTE 5400 of 18 Jun 2003)

1. Purpose. To approve establishment of subject fleet activity under the administrative chain of command of the Chief of Naval Operations per reference (a).

2. Background. This establishment is part of the realignment of Explosive Ordnance Disposal (EOD), Expeditionary Salvage, Naval Coastal Warfare (NCW) and Mobile Security Forces (MSF) under one command with primary responsibility for Title 10 functions. COMARFPCOM will centrally manage current and future readiness requirements and resources, and ensure common training and Tactics, Techniques and Procedures (TTP) are executed worldwide for these specialized expeditionary forces.

3. Organizational Change. Establish Commander, Maritime Force Protection Command at Norfolk, VA, effective immediately, to be fully operational NLT 1 October 2004. The following applies:

b. Mission. To provide administration and support, oversight and distribution of resources and authorized equipment, personnel management, force maintenance and logistics, individual and unit training, and leadership for all (EOD), Expeditionary Salvage, (NCW), and (MSF) forces to produce

and maintain combat ready forces capable of meeting the Operational Commanders' requirements.

c. Major Claimant. COMFLTFORCOM

d. OPNAV Resource Sponsor. N75

e. Administrative Chain of Command. Chief of Naval Operations to be exercised by:

4. Action
