SUBJECT: National Coordination of Emergency Relocation Sites (S)

The President has approved the attached National Security Decision Directive (NSDD) establishing policy on coordination of Emergency Relocation Sites (ERS). This directive provides a formal mechanism for coordinating the selection of ERS to prevent conflicts that would lessen the effectiveness of U.S. Continuity of Government plans and procedures.
