

## **REPORT TO CONGRESS**

### **DEPARTMENT OF DEFENSE FISCAL YEAR 2005** **PURCHASES OF SUPPLIES MANUFACTURED** **OUTSIDE THE UNITED STATES**

**March 2006**

**Office of the Under Secretary of Defense (Acquisition, Technology & Logistics)**  
**Defense Procurement and Acquisition Policy**

#### **Background**

Section 641 of the Transportation, Treasury, Independent Agencies and General Government Appropriations Act, 2005 (Division H of the Consolidated Appropriations Act, 2005 (Pub. L. 108-447)), requires the head of each Federal Agency to submit a report to Congress on the amount of acquisitions made by the agency from entities that manufacture the articles, materials, or supplies outside of the United States in that fiscal year. The report shall separately identify (1) the dollar value of any articles, materials, or supplies purchased that were manufactured outside the United States; (2) an itemized list of all waivers granted with respect to such articles, materials or supplies under the Buy American Act (BAA); and (3) a summary of the total procurement funds spent on goods manufactured in the United States versus funds spent on goods manufactured outside the United States.

#### **Discussion**

This report includes four sections: (1) all procurements from foreign entities and more specifically, purchases of articles, materials, or supplies/manufactured goods from such foreign entities; (2) manufactured products provided by U.S. suppliers with a manufacturing place of performance overseas; (3) waivers granted with respect to such articles, materials or supplies under the Buy American Act (BAA); and (4) a comparison of procurement funds spent on goods manufactured in the U.S. versus funds spent on goods manufactured outside the U.S.

The information presented in this report addresses Fiscal Year 2005 and is based on DD Form 350 data compiled and distributed by DoD's Washington Headquarters. The DD Form 350, Individual Contracting Action Report, includes data on contracting procedures, competition, financing, statutory requirements, socioeconomic programs and other information relating to DoD acquisitions. In some instances, the exact information required by section 641 is not available and DoD has made assumptions in order to complete the report. In those cases, the report identifies the methodology and assumptions made by DoD in responding to the reporting requirement.

## Section 1 - Procurements from foreign entities

**1(a) All procurements.** DoD procurement actions recorded on DD 350's during FY 2005 totaled approximately \$269 billion. Of that amount, approximately \$18.3 billion or 6.8 percent was expended on purchases from foreign entities. Of this amount, \$16.8 billion is for contracts with a place of performance outside the U.S. and the remainder, \$1.5 billion, is for contracts with a place of performance within the U.S. A detailed breakout of the dollars by country is contained in **Table 1**.

The \$18.3 billion covers military hardware, subsistence, fuel, construction, services, and other miscellaneous items that are for use outside the U.S. Services constitute 24.2 percent of the total, with fuel and construction accounting for 24.6 percent and 19.5 percent, respectively. **Table 2** provides a breakout of the \$18.3 billion by defense claimant program (DCP) and percentage of total.

In comparison, Defense Security Cooperation Agency data reflect foreign purchases of U.S. defense articles and services in Fiscal Year 2005 totaling approximately \$10.6 billion. Data from the State Department reflect that U.S. manufacturers obtained export licenses for direct commercial sales licensed under the Arms Export Control Act in the amount of \$30.1 billion in Fiscal Year 2005.

**1(b) Procurement of manufactured articles.** This section focuses strictly on defense articles provided by foreign entities that are manufactured outside the U.S. Of the approximately \$18.3 billion that was expended on **all** purchases from foreign entities defined by Defense Claimant Program (DCP), **Table 3** notes that approximately \$8.8 billion was expended on contractual actions for the procurement of articles manufactured outside the U.S. **Table 3** refines the data in **Table 2** to remove all dollars associated with petroleum, other fuels and lubricants, subsistence, construction and services (DCPs A8A, A8B, B2, C3, and S1) to derive the \$8.8 billion for articles manufactured outside the U.S. **Table 3** further refines this data to exclude all activities/services included in the \$8.8 billion in DoD procurements from foreign entities that are not actually associated with manufactured goods. For example, Column 1 in **Table 3** reflects a total of \$303,863,844 for DCP A1A. However, after removal of costs associated with various aircraft related services, the adjusted figure for A1A is only \$259,408,785 as reflected in column 2. Similar adjustments were made to the remaining DCPs, resulting in an adjusted total of \$8.2 billion for procurement of articles manufactured outside the U.S. by foreign entities. **Table 4** provides a detailed breakout of DoD purchases by foreign country, dollars, and number of actions. **Table 5** refines the data even further to provide visibility into this information by DCPs, country, dollars and the number of actions.

## **Section 2 – Purchases of manufactured products from U.S. suppliers with a manufacturing place of performance overseas.**

In addition to the procurement of manufactured articles discussed in section 1 above, data from the DD 350 reflect that in Fiscal Year 2005, the Department procured approximately \$ 270.2 million in supplies from U.S. companies where the place of manufacture was listed as a foreign country. **Table 6** provides an overview of these procurements.

## **Section 3 - Waivers of the BAA granted with respect to such articles, materials or supplies.**

DoD has no central repository for waivers of the BAA and such information is not available in the existing DoD database. It is, therefore, not possible to identify which of the manufactured articles identified in section 1 of this report required a waiver of the BAA. Instead, this report attempts to identify the dollar value of DoD purchases of manufactured goods for which it is believed that the BAA may have been waived as a result of various international agreements. The following methodology was used to estimate dollars in this category:

1. Since the BAA does not apply to purchases for use outside the U.S., contracting actions by overseas buying offices were excluded from the data. However, purchases by these offices are included in the data for Section 1 above.

2. It is assumed that all procurements covered by Memoranda Of Understanding, the Trade Agreements Act (TAA) and any other international agreement resulted in a waiver of the BAA. It should be noted, however, that using this methodology overstates the dollar value of items for which the BAA was waived. The Act does not apply when a domestic item's cost is unreasonable, the domestic preference is not in the public interest, or sufficient quality and quantity is not available domestically. Since we do not have data on when the Act did not apply in these circumstances, adjustments to the data can not be made for those events.

**Table 7** contains a detailed breakout of procurement actions by country and type of agreement. This breakout details procurement actions as follows:

1. Actions pursuant to the Caribbean Basin Economic Recovery Act.
2. Actions under the TAA (Agreement on Government Procurement).

3. Actions under Free Trade Agreements (FTAs)
  - a. The North American Free Trade Agreements (NAFTA).
  - b. Chile FTA
  - c. Singapore FTA
  - d. Australia FTA
  - e. Morocco FTA
  
4. Actions under MOUs.

DoD purchases under #s 1, 2 and 3 above all fall within the same supply categories and are comprised of mostly commercial and dual use items. Defense equipment is excluded from coverage under these agreements. The thresholds for the various trade agreements vary in terms of applicability and are subject to revision by the U.S. Trade Representative every two years. In some instances, a country may have an FTA with the U.S., be a signatory to the TAA, and also have an MOU with DoD. As a result, purchases will be reported in more than one category. The following is a breakout of how DoD purchases are reported in those instances:

Canadian products subject to North American Free Trade Agreements (NAFTA) coverage equal to or exceeding \$25,000 but below the Fiscal Year 2005 TAA threshold of \$175,000 are reported under NAFTA. Procurement actions equal to or exceeding \$175,000 with Canada for TAA code covered products are included under the TAA portion of the report. All other procurements of Canadian products are reported under the MOU section.

Mexico is not a party to the Agreement on Government Procurement under the TAA and does not have a reciprocal procurement MOU with the U.S. Accordingly, all DoD purchases of Mexican products equal to or exceeding \$58,550 are reported under NAFTA.

Chile is not a party to the Agreement on Government Procurement under the TAA and does not have a reciprocal procurement MOU with the U.S. Therefore, all DoD purchases of Chilean products equal to or exceeding \$58,550 are reported under the Chile FTA.

Singapore products subject to FTA coverage equal to or exceeding \$58,500 but below the Fiscal Year 2005 TAA threshold of \$175,000 are reported under the Singapore FTA. Procurement actions over \$175,000 with Singapore for TAA code covered products are included under the TAA portion of the report. DoD does not have a reciprocal procurement MOU with Singapore.

Australian products subject to FTA coverage equal to or exceeding \$58,550 are reported under the Australian FTA. Australia is not a party to the Agreement on

Government Procurement under the TAA but does have a reciprocal procurement MOU with the U.S. Therefore, all DoD purchases of Australian products not covered by the FTA are reported under the MOU section.

Morocco is not a party to the Agreement on Government Procurement under the TAA and does not have a reciprocal procurement MOU with the U.S. Therefore, products subject to FTA coverage equal to or exceeding \$175,000 are reported under the Moroccan FTA.

Using the methodology described above, the various international agreements for which it is assumed that the BAA was waived totaled approximately \$4,027.5 million in Fiscal Year 2005.

**Section 4 - Comparison of procurement funds spent on goods manufactured in the U.S. versus funds spent on goods manufactured outside the U.S.**

**Table 8** presents a comparison of contractual actions and dollars for procurement of goods manufactured by U.S. sources versus goods manufactured by foreign sources. As reflected in table 6, DoD's procurement of manufactured goods from U.S. sources totaled approximately \$97.3 billion as contrasted to DoD purchases of manufactured goods from foreign sources which totaled slightly more than \$8.2 billion, or roughly 8% of all DoD's procurement of manufactured goods in Fiscal Year 2005. In addition, DoD purchased approximately \$270.2 million from U.S. suppliers with a manufacturing place of performance overseas.

Column 1 is a dollar summary of all DoD procurement actions, both obligations & deobligations, during FY 2005 for the DCP's shown above. Not included in column 1 are the costs associated with petroleum, other fuels and lubricants, subsistence, construction and services (DCP's A8A, A8B, B2, C2 and S1). These dollar values are the same values shown in DoD's annual report to Congress on **purchases from foreign entities** for these specific DCPs.

Column 2 is a dollar summary of the dollar value of defense articles provided by foreign entities that are manufactured outside the U.S. The difference between column 1 and 2 is that the value of services associated with this hardware has been removed. For example, R&D, Professional Services, Maintenance, Repair & Refurbishment, transportation, housekeeping services, etc. have been excluded. Column 2 is our estimate of the value of articles, materials, and supplies manufactured outside the US by foreign entities.
