



THE NATIONAL CLEARINGHOUSE FOR EDUCATIONAL FACILITIES (NCEF)

The National Clearinghouse for Educational Facilities is a free public service that provides information on planning, designing, funding, building, improving and maintaining safe, healthy, high-performance schools. To visit, go to www.edfacilities.org. NCEF is managed by the National Institute of Building Sciences (NIBS).

NCEF's Web site receives approximately 80,000 hits a month from visitors all over the world. The Web site's primary audience includes school administrators, architects, facilities staff, teachers, parents, school board members and members of the media.

NCEF provides resources on anything related to a school campus and its buildings. According to Judy Marks, associate director of NCEF, "When you build a school, you have one shot at getting it right. Our Web site provides an effective way for people to get information on best practices to ensure that school buildings are efficient, healthy and secure."

The Safe School Facilities Web Page

NCEF offers a wealth of information related to safe schools and disaster preparedness. NCEF's disaster preparedness efforts began shortly after the Sept. 11, 2001, terrorist attacks. Its "Safe Schools" section (www.edfacilities.org/safeschools/) addresses all components of school campuses (e.g., buildings and grounds) that help to ensure the physical security of school occupants not only during terrorist

attacks, but also during natural disasters, inclement weather, fires, criminal acts and other incidents. This information is coordinated with the U.S. Department of Education's Office of Safe and Drug-Free Schools (OSDFS). The Web page also includes news, events, resource lists, articles and publications.

The Resource Lists Web Page

NCEF's "Resource Lists" Web page (www.edfacilities.org/rl) is composed of subject-specific lists that can be "huge time savers," says Marks. Each subject area includes links to online publications and related Web sites, as well as descriptions of pertinent books, studies, reports and articles. Following is a list of ERCM-related topics:

- **Disaster Preparedness** offers recent articles related to school preparedness, including information on developing emergency preparedness plans and the use of schools as shelters in emergency situations.
- **Hazardous Materials in Schools** covers anything related to hazardous materials (e.g., securing and storing hazardous materials and environmental hazards).
- **Access Control Systems** contains a number of books and articles on access control, such as the use of cameras, student identification (ID) systems and locking mechanisms.
- **Fire Safety** identifies a number of books and articles related to fire safety.

- **Safety and Security Design for Schools** provides resources on design elements that contribute to school safety, such as landscaping, access control and construction methods.
- **State Emergency Planning Guides** consists of policies and sample emergency plans from a number of states and localities. The plans offer examples of useful policies and practices that districts can incorporate and modify to fit their own crises plans.



The Safe School Facilities Checklist

NCEF has added a new feature to its Web site: the Safe School Facilities Checklist, available at www.edfacilities.org/checklist/checklist.cfm. The checklist is designed for assessing and improving the safety and security of school buildings and school grounds. Created by NCEF and funded by the OSDFS, the checklist combines best practices in school facility assessment measures into one comprehensive online tool. Nationally recognized school facilities experts participated in the checklist's creation and oversee its periodic updating.

The checklist applies the basic principles of Crime Prevention Through Environmental Design (CPTED), such as:

- **Natural Surveillance:** Unobtrusively observing a particular setting;
- **Natural Access Control:** Restricting who may enter or exit an environment; and
- **Territoriality and Maintenance:** Demonstrating ownership and respect for property.

Facility assessments are best performed by experienced building and safety professionals working closely with school officials. The assessment team is best led by a school CPTED specialist, and the team should include the school or district facility manager, the principal, and other personnel as appropriate, including the head custodian, a teacher, the school resource officer, the local fire inspector, and any architectural, engineering or security professionals needed. The assessment team for a new school or renovation should also include the project's planner and architect. The team conducts reviews during the schematic phase and at the 30 and 95 percent completion stages, their goal being to get things right as early in the process as possible.

Not all of the assessment measures in the checklist apply to every school; therefore, the checklist was constructed to allow online users to tailor it to their school facility by selecting only those categories and subcategories that are appropriate. The information selected can then be downloaded into an Adobe file.

More on NCEF

Whenever possible, NCEF includes full-text versions of documents rather than simply linking to outside sites that might change their content. When outside links are chosen and posted, efforts are made to ensure that these links are not broken (i.e., Web links will bring you directly to the site promised, not to an error page).

A number of useful categories for the ERCM community are maintained on the Web site:

- **News** presents summaries and links to news stories about educational facilities. They are listed in reverse chronological order, from the present to approximately three months past. To submit a relevant news story, go to http://www.edfacilities.org/ne/news_submit.cfm.
- **Calendar** lists information on conferences, courses, workshops, competitions, trade shows and press conferences, all related to educational facilities, their safety and their security. NCEF would like to include more events for people interested in safety and security issues. To submit a relevant event item, go to <http://www.edfacilities.org/cal/CalendarAdd.cfm>.
- **Publications** provides a list of publications developed by the NCEF. Publications are available in print and online in HTML and PDF formats. Hard copies of these publications can be requested by submitting

a request with the online NCEF order form, available at <http://nibs.org/pubsncef.html>. Publications are sorted alphabetically or by topic (Financing; History and Research; Maintenance and Operations; Planning; Design and Construction; Safe and Healthy Schools; School Spaces and Grounds; and Technology). A search engine is also available, which provides direct access to NCEF's extensive database.

- **Construction Data** contains a number of resources related to school construction, such as the McGraw-Hill Historical and Forecast Data, and the *American School and University Education Construction Report, 2005*. It also addresses issues such as cost estimating data and tips on professional cost-estimating services.
- **Links** connects to professional organizations; federal, state and municipal resources; academic research centers; media; and products and services.
