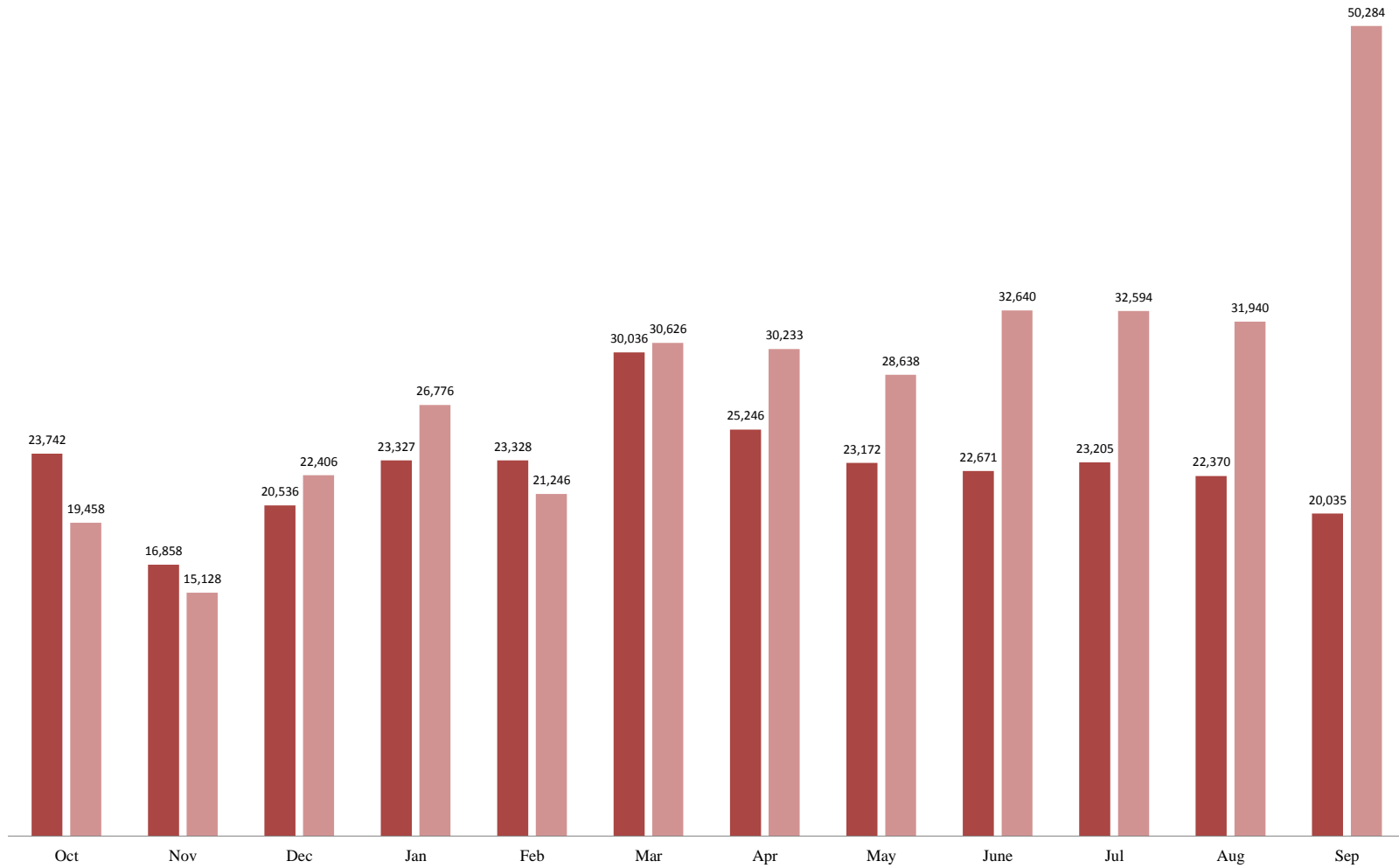

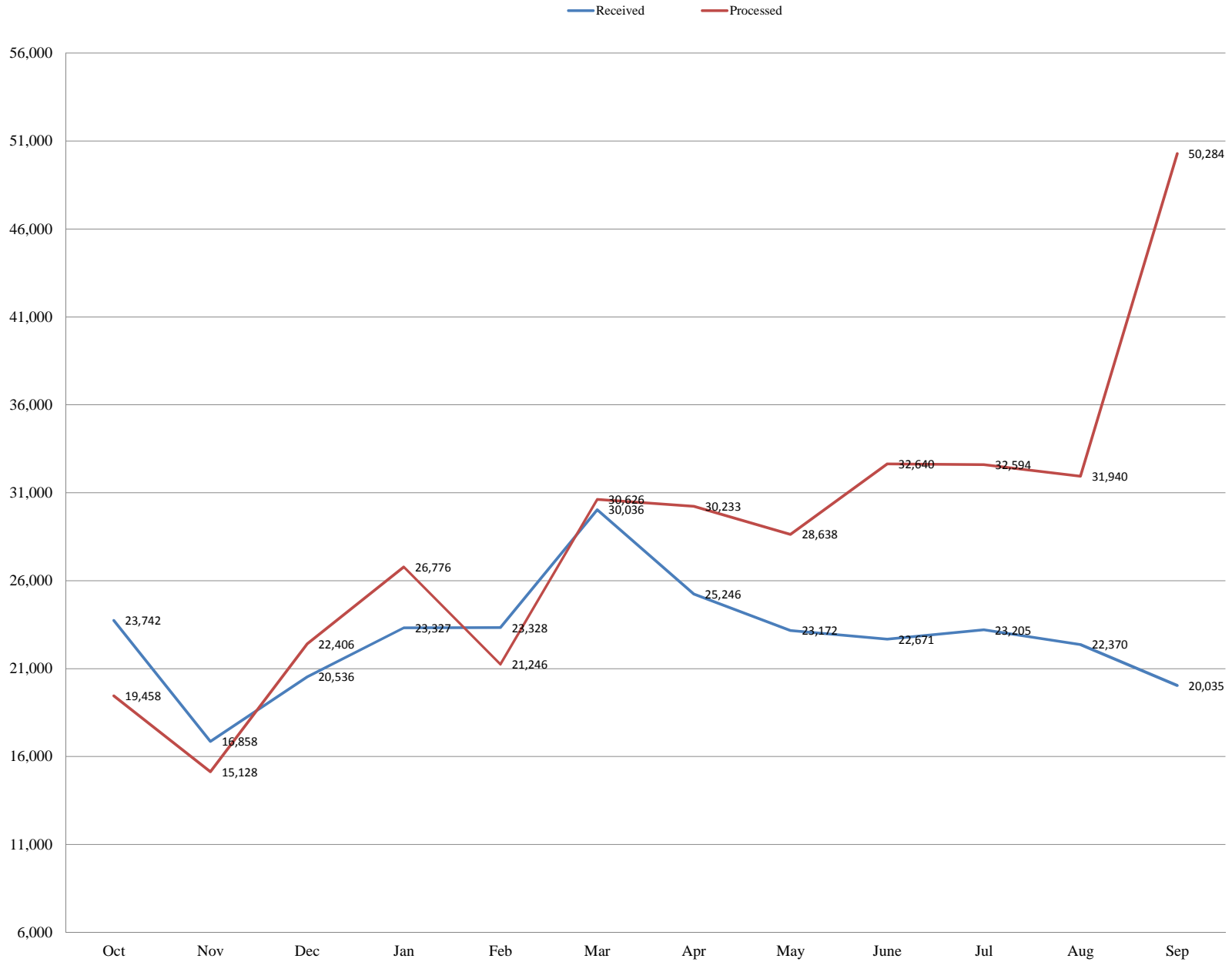
Composite DHS Monthly Production Rate of Received and Processed FOIA Requests

Received Processed



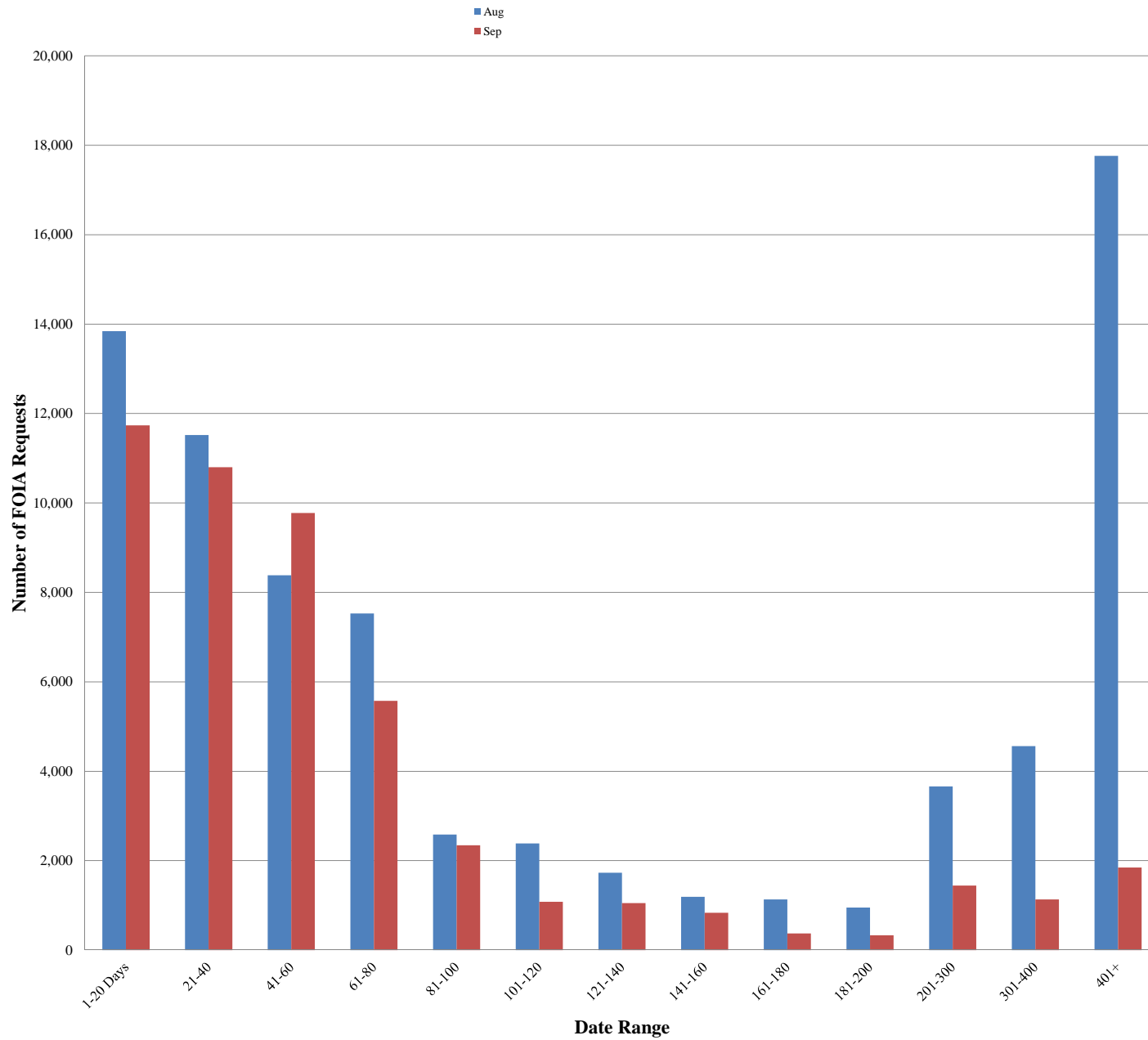
